Moved by Mr. Rowe, supported by Mr. Siler, to approve payment of bills and payrolls in the amount of \$ 210,452.40, covered by vouchers #12/13-037, #12/13-039 and #12/13-040, and payroll voucher #12/13-038.

Moved by Mr. Rowe, supported by Mr. Siler, to approve the minutes of the March 25, 2013 regular monthly meeting.

Engineers, as it would cost the Houghton County Road Commission, more than seven (7) times the amount stated in the agreement to replace the sand, if they had to purchase it from another source.

Moved by Mr. Rowe, supported by Mr. Siler, to authorize payment of invoice #2013-331, from the County Road Association of Michigan, for the membership service charges for the year ending March 31, 2014, in the amount of \$ 6,951.00.

Moved by Mr. Rowe, supported by Mr. Siler, to recommend continuing our service contract with Computer Mechanix, regarding any computer tech work.

Moved by Mr. Rowe, supported by Mr. Siler, to accept the 09/30/2012 audit, prepared by Rukkila/Negro and Associates, which Kevin explained to the board.

Motion Carried.

Moved by Mr. Rowe, supported by Mr. Siler, to approve of a 2013 Employee Appreciation-Safety Awareness Day, Fifth Annual, to be held at the Hancock Beach, whereas budget issues and safety issues will be discussed. All employees in attendance will be granted five (5) hours of vacation time to be used at a later date. The Road Commission will contribute up to \$1,500 towards the event as they have in the past.
